Sandyston Township Volunteer Fire Department Celebrates 70th Anniversary



Congratulations to the Sandyston Township Volunteer Fire Department on their 70th Anniversary.

Today, our beautiful new fire house is brimming with both pride and appreciation for the dedication of our loyal members and volunteers, past and present, and the support of the community.

How did our fire department begin?

"On June 22, 1953, the Sandyston Methodist Church was having a Father/Son Dinner. During the evening a group gathered outside the church and casual mention was made as to the dilapidated condition of "the old church across the road".

Due to lack of funds, the Hainesville Methodist Church was unable to keep up with the increased maintenance of the former church building. Many meetings were held within the next month and at a public meeting held July 27, 1953, at the Grange Hall in Layton, it was unanimously decided to organize and incorporate a fire department and community center. Calvin Agar, Frank B. Ayers and Harry C. Harper were designated as Trustees for the purpose of Incorporation. An Organizational Meeting was held at the Grange Hall in Layton on October 1, 1953 and Agar, Harper and Ayers were re-elected as trustees. Officers elected were Lawrence C. Ellet, President, Abe Aber, Vice—President, George Barnard, Secretary, Benjamin Jager,



Treasurer, Edward Spears, Chief, Edward Hull, Jr., Assistant Chief, and Rev. Harold Green was appointed as the department's Chaplain. The first meeting was held on December 10, 1953 in the reconstructed church basement. A special 24 hour celebration was held to commemorate the dedication and formal opening of the building on Saturday, July 3, 1954. This building served as a fire house and community center for 50 years until the Sandyston Township Municipal Building and Fire Department Complex was built across the street and dedicated on September 25, 2004. The former fire department was then sold to the St. Thomas the Apostle Church to be used as an education center."

DEER CARCAS REMOVAL



During the fall and winter, we experience higher incidents of deer being hit or injured by automobiles. If you live on a Township, County or State Road and notice a deer that has suffered the effects of an automobile accident, please call

and report this to the municipal building as soon as possible. We will do our best to expedite the removal of the deer by contacting the appropriate agency Please be advised, it can take up to 24 hours once we make the call and there is no removal on the weekends..

Please also be advised, should a dead deer be found on your property it is your responsibility to have this deer removed. The service for deer removal does not extend to residential property.

You may report this information by calling 973-948-3520 extension 200 or 201. Should you leave a message, please be sure to leave information on the location of the deer (road name, nearest intersection, mile marker, nearest residence or landmark) to help in the removal of the deer.

Municipal Landscaping Refresh



After 20 years, many of the trees and shrubs around the municipal building had become overgrown, discolored and unmanageable. While the trees and shrubs were beautiful when first planted, through the years we found the trees could not remain so close to the building and the shrubs could not be trimmed back any as parts of them had started crowed each other and began to die. They had started to outgrow the space they were in and it was time for a refresh.

In October, the Township Committee requested proposals from local landscape architects for the removal of the trees and shrubs, installation of new, low maintenance shrubs, and fresh mulch. David H. Wright Landscape Architect of Branchville spent about a week working on the project.






There is no fee to drop off your tires at the garage; however, you must be a township resident and only four tires per household will be permitted.


BOOK DONATIONS

Dear Sandyston Community:

I am thrilled to join your community as Sandyston-Walpack School's new Principal and Supervisor of Special Services. The school year is going great; meeting so many families and residents around the community has been a pleasure.

As a sixteen-year educator and parent of three grown children, I share with our community the desire to see our students grow, succeed, and enjoy learning. It is a gift as an educator to join a community like SWS, where there is a rich tradition of positively impacting young lives and setting them on a path to becoming lifelong learners. My goal here at SWS is to build on all the strengths already in place and develop a learning community grounded in trust and collaboration. As a neighboring resident just one town over, I am an invested and dedicated citizen of our school community, which makes this principalship all the more special for me and my family.



I join the SWS team after four years of middle school administration. Before this work, I taught fifth-grade Language Arts/Social Studies for nine years and completed three years of assignments in grades kindergarten, three, and four. My special education certification allowed me to teach at a K-5 summer extended school year program for many years. My heart is so full returning to our elementary setting!

Some of our important initiatives at SWS this year include:

- We have departmentalized our third and fourth grades. Departmentalization means our students have one teacher for math/science and another teacher for English/Social Studies. This structure provides our upper grades 3-6 students with highly specialized and trained teachers in vital content areas.
- This year's building goal is to strengthen our inclusive education practices and ensure we are meeting all students' diverse needs and abilities in the classroom. We are focusing on impactful co-teaching techniques, academic intervention, small group teaching strategies, and analyzing classroom and state testing data to reflect and improve our teaching strategies.

Schoolwide Student Recognition Program

The goal of the Caught Being Kind program is to foster a positive, helpful culture in the school. A safe and comfortable environment is crucial for students to learn and grow. It's important that we recognize and praise kindness in our students in any way, shape, or form.

Nominations for staff or students can be made by faculty to SHOUT OUT someone for going above and beyond, reaching a goal, helping out, giving a best effort, persevering, etc. A SHOUT OUT can be for something in or out of school. SHOUT OUTS are a great way to spread good news in the community!



When someone gets a SHOUT OUT their name and nomination goes on the principal bulletin board, and students get to call home with the principal to share the news. Nominees also get a SHOUT OUT sticker to wear all day, their accomplishment gets displayed on our SWS Shout Out bulletin board, and it's announced in the morning announcements.

PositiviTEE Days at SWS

FREE RABIES CLINICS

Please remember, these dates are subject to change

and you should verify them before attending, as well as question if you are required to bring any paperwork about your pet with you. This could be the difference between a one-year or three-year vaccination. Remember to have your dog on a leash and your cat in a carrier!

Lost/Found Pet Checklist



We have all been there, you open the door and your pet is gone in a matter of seconds. In the panic, you can't think of who to call to get help. In situations like this, be sure to contact the following for help:

- ⇒ Call Animal Control: 973-670-3299.
- ⇒ Call the municipal building: 973-948-3520 x200/201
- ⇒ Call the New Jersey State Police 973-383-1514 (this is their non-emergency line)

Is your property near a State or Federal Park?

- ⇒ Stokes State Forest Office 973-948-3820
- ⇒ Delaware Water Gap National Recreation Area Dispatch 570-426-2457
- ⇒ Call Kountry Kennels 973-948-0624 -Dog Pound Facility
- ⇒ Call your neighbors

Give each agency a good description of your pet (name, type, color, collar/no collar, license number, microchipped, etc.) and a picture if they ask for one.

What's next?

- ⇒ Drive around and look for your pet
- ⇒ Do you have social media? Post on your page.
- ⇒ Make flyers and post in local businesses and neighboring towns
- ⇒ List your pet on local lost and found websites

Once you find your pet, be sure to contact everyone and let them know so information can be updated.

Dog License Renewals!



Please remember dogs must be licensed at six months old. If you currently have a dog or recently moved to Sandyston and you did not obtain a license— please call the Municipal Clerk.

You may obtain a dog license application at the municipal building or on the Township website:

www.sandystontownship.com

Remember to provide spay/neuter information & valid rabies certificate with an expiration date of at least November 1, 2024 (per State of New Jersey). Dog licenses fees \$13 unaltered/\$10 altered.

Dog licenses expire in December of each year. Be on the look out for the renewal letter and send your information in as soon as possible to avoid late fees and Court costs.

Keep Them Close

If you find a lost dog in your travels, please report this to the local authorities where the dog was found immediately.

If you are willing to stop and help the dog, then you must be willing to keep them close where they are found. Removing this dog from the area you found it causes confusion and makes it harder for the owner to get their dog back.

Your first call should always be to the New Jersey State Police non-emergency phone (973-383-1514. They will contact Animal Control and advise you where to take the dog. This allows the proper authorities to be notified and a quicker return of the dog to the owner.

Be Sure to Clean Your Chimney on a Regular Schedule



It is extremely important to have your chimney cleaned. How often depends on how regularly you use your fireplace or woodstove.

Why should you clean your chimney?

It is important to remove debris/sticky deposits deposited along the chimney

walls. The sticky deposits are called creosote. Creosote deposited over a long period becomes highly flammable and it's often the cause of chimney fires. Creosote removal is vital to your safety.

It's important. VERY IMPORTANT!

When was the last time your chimney was cleaned? Protect your home, yourself and/or your family by getting your chimney properly cleaned.

<u>ALWAYS REMEMBER</u> to properly dispose of ashes in a safe location/receptacle <u>AWAY</u> from your home.

Sandyston Township Volunteer Fire Department and lives in Montague with his wife, Betty.



Important Tax Office Reminders



ANCHOR Deadline Approaching



ANCHOR (formerly Homestead Rebate) benefit filing season is under way.

If you received an "ANCHOR Benefit Confirmation Letter" and did not make any updates

to your application by **September 30, 2023**, no further changes can be made to your application at this time.

Payments have started being made both electronically and through the mail. Most applicants can expect to receive their payment approximately 90 days after filing the application, unless the State of NJ requests additional information to process your benefit.

Filing Deadline

There is still plenty of time to file. You have until **Friday**, **December 29**, **2023**, to file an application.

How to Apply

Taxpayers who received a green or purple filing packet should follow the instructions in the packet to apply for their benefit. If you meet the qualifications for the benefit based on 2020 residency, income, and age eligibility - but you did not receive a packet from the State of NJ- you may still apply for the program.

Homeowners. Most homeowners may file online or by phone with an identification number (ID) and PIN. However, if you bought your home in 2020, altered your deed, or had certain life changes such as a divorce or death of a spouse, you must file an application by mail.

Renters. Renters may file using the online option. They **do not** need an ID and PIN

Scam Alert

Scammers often send you texts or emails to steal your identity. The State of NJ will never initiate a text exchange to request personally identifiable information regarding your ANCHOR benefit. Contact them directly before providing personal information in response to communications you receive claiming to be related to the ANCHOR program. Visit their Scams page for more information.

Property Tax Reimbursement (Senior Freeze or "Blue Book") Important Reminder

The Senior Freeze Program reimburses eligible senior citizens and disabled persons for property tax on their principal residence. To qualify, you must meet all the eligibility requirements for each year from the base year through the application year (the next application year will be 2023).

If you have already filed the PTR-1 Application, the State of NJ will mail the PTR-2 application to you in March or April to the to the last filed address. It is important that you keep track of this booklet and file each year **so you do not lose your base year amount**. If you do not receive a PTR-2 booklet, contact the Senior Freeze Property Tax Reimbursement Information Line for assistance at 1-800-882-6597. It is very important that you file every year. Do not wait until the last minute!

Qualifications for the Senior Freeze have changed. Be sure to contact the Tax Collector in the Spring to seek information on this program if you are 67 years old or older!

Sandyston Township Offers Many Ways to Timely Pay Taxes

There are many ways to pay your property taxes due to Sandyston Township:

- US Mail (remember to mail plenty of time before due date and follow up to be sure the taxes were received on time to avoid late fee—postmarks are not accepted per NJ Statute.)
- Drop off at municipal building either in person or by using drop box (green—secured to building) to the left of the front door.
- You may make payments online by accessing the township website: www.sandystontownship.com/departments/tax. (On Tax Collector Page)

There is a 2.965% fee if your payment is made using a credit or debit card and a flat fee of \$1.50 for payments made using an e-check.



Important Tax Office Reminders



UNDERSTANDING ADDED AND OMITTED TAX BILLS



It is only logical that an improvement to your home will result in an increased selling price of your home and therefore, your property tax assessment will increase.

This will take the form of an added assessment tax bill which you will receive in the mail on or about October 25th after the improvement is substantially completed for its intended use. This bill shall be payable on November 1st, February 1st and May 1st and then the added assessment amount will be included in your annual tax bill received in June for the new tax year. Therefore, just as you planned ahead for this improvement, you should also plan ahead and set aside funds for the added assessment tax bill.

Difference between an "Added Assessment" and an "Omitted Added" Assessment:

The added assessment is the amount of the difference between the property assessment before the improvement and the value of the entire property after the improvement. It does not reflect the cost of the amenity itself or the cost of the project. If you did not receive an added assessment tax bill for work completed in the previous year, you will receive an "Omitted Added" assessment bill in addition to an "added assessment" bill the year following the improvement.

"A structure is considered 'completed' when it is ready for the purpose for which it was intended. This does not mean that the structure actually must be in use; it does not have to have a certificate of occupancy; it is taxable when it is ready for use."

- This added bill is to be paid in addition to the original tax bills that were mailed out at the end of August.
- Added bills are due in three installments (like regular tax bills), on November 1st, then February 1st and May 1st of the succeeding year.
- The first added tax payment is due November 1. The last day to pay without penalty is November 10.
- If there is a mortgage, they will also receive a copy of this added/omitted tax bill. You will then receive an advice copy of the added/omitted tax bill.

<u>Important:</u> If you have a mortgage company escrowing for taxes, they may or may not pay this bill for you, depending upon your particular agreement with that company. Some mortgage companies will NOT pay added assessment bills, simply because they have not escrowed enough tax money from you to pay it. You are advised to call your mortgage company to determine which of you should pay the three installments shown on the bill. The Tax Collector's office does not know which party will be responsible for this payment. A bill is mailed to both the homeowner and the mortgage company, so that both parties are aware of the amounts due.

<u>Please note:</u> Not scheduling a final inspection for your building permit does not delay the added assessment tax bill.

If you disagree with the Added or Omitted Assessment that is placed on your property, you can appeal it to the Sussex County Board of Taxation prior to December 1. An appeal form can be requested from the Sussex County Board of Taxation or found on their website.

Do I Need A Permit??

Contact the Construction Official

Zoning Approval and Construction Permits are required for certain types of installations, remodeling, renovations and repairs around your home. If you are unsure if you need zoning approval or a construction permit, please contact the Construction Department and speak to the Construction Official, Robert Huber, who will provide you with the information and forms necessary. Zoning Permits are required when you change the footprint of the existing property (decks, additions, sheds, pools, etc.).

Construction permits are required for tank installations and removals (propane or oil), deck installation and repairs, additions, remodeling/alteration of rooms, electrical and plumbing work, wood stoves, pellet stoves, gas appliances, sheds, pole barns, air conditioning and generator installation, furnace replacement, water heater replacement, pools (all kinds), hot tubs and more. To be sure a permit is/is not needed please call!

Please remember, realtors and potential homebuyers check for permits to be sure the work was done to code!

Doing the work yourself? That's great! But if you are using a contractor, be sure to have that contractor fill out, seal (if required) and sign the permit. If you have a contractor, but fill out the permit under your name—you have no recourse should a problem arise!

Your home is a huge investment—be sure to protect your investment and ensure the safety of your family by making sure to take out a permit!

Switching Propane Companies Information on Permits



Thinking about changing propane companies?

If you rent your propane tank(s) and you decide to change propane companies you need a permit. The propane company you are leaving will remove the old tank (s) and the new propane company of your choice will bring and set the new tank(s) and pressurize the line for the air test inspection to be sure it holds before the pro-

pane is added to the tank(s).

If you own your tank(s), you do not need a permit to change propane companies. You simply call and cancel service with your current propane company and initialize service with the new company.

Why do you need a permit?

Inspections check location of the tank, proximity to combustibles, windows, and property lines, connection of the gas lines and pressure test the tank. The safety of you and your family is the most important thing!

Wood Stove, Pellet Stove, Gas Insert Permits Required



With electric, oil and gas prices higher these days.....many families are looking to supplement the heat in their home.

Whether you decide on a wood stove, pellet stove or a gas insert (or similar unit) a permit is required for this install. Make sure you get the most out of your purchase by taking out the proper permits and having these types of units inspected. Many insurance companies will want a copy of the certificate of approval showing these units were properly inspected. In the event of a problem, insurance companies will contact the municipality to find out if proper permits were taken out for this installation. What is the inspection for? Inspections check the clearance to combustibles, make sure the door is properly sealed, proper fire protection in front of or behind the unit and inspect the chimney (if needed). Contact the Construction Department at 973-948-3520 x201 to discuss your purchase,

obtain the proper permits and schedule your inspections.

Solutions to Stormwater Pollution: Easy Things You Can Do Every Day To Protect Our Water A Guide to Healthy Habits for Cleaner Water





Pollution on streets, parking lots and lawns is washed by rain into storm drains, then directly to our drinking water supplies and the ocean and lakes where our children play. Fertilizer, oil, pesticides, detergents, pet waste, grass clippings: You name it and it ends up in our water. Stormwater pollution is one of New Jersey's greatest threats to clean and plentiful water. By sharing the responsibility and making small, easy changes in our daily lives, we can keep common pollutants out of stormwater. It all adds up to cleaner water, and it saves the high cost of cleaning up once it's dirty. As part of New Jersey's initiative to keep our water clean and plentiful and to meet federal requirements, many municipalities and other public agencies including colleges and military bases must adopt ordinances or other rules prohibiting various activities that contribute to stormwater pollution. Breaking these rules can result in fines or other penalties.

As a resident, business, or other member of the New Jersey community, it is important to know these easy things you can do every day to protect our water.

Limit your use of fertilizers and pesticides: Do a soil test to see if you need a fertilizer. Do not apply fertilizer if heavy rain is predicted. Look into alternatives for pesticides. Maintain a small lawn and keep the rest of your property or yard in a natural state with trees and other native vegetation that requires little or no fertilizer. If you use fertilizers and pesticides, follow instructions on the label on how to correctly apply the product. Make sure you properly store or discard any unused portions.

Properly use and dispose of hazardous products: Hazardous products include some household or commercial cleaning products, lawn and garden care products, motor oil, antifreeze, and paints. Do not pour any hazardous products down a storm drain because storm drains are usually connected to local waterbodies and the water is not treated. If you have hazardous products in your home or workplace, make sure you store or dispose of them properly. Read the label for guidance. Use natural or less toxic alternatives when possible. Recycle used motor oil. Contact your municipality, county or facility management office for the locations of hazardous-waste disposal facilities.

Keep pollution out of storm drains: Municipalities and many other public agencies are required to mark certain storm drain inlets with messages reminding people that storm drains are connected to local waterbodies. Do not let sewage or other waste flow into a stormwater system.

Don't litter: Place litter in trash receptacles. Recycle. Recycle. Recycle. Participate in community cleanups.

Dispose of yard waste properly: Keep leaves and grass out of storm drains. If your municipality or agency has yard waste collection rules, follow them. Use leaves and grass clippings as a resource for compost. Use a mulching mower that recycles grass clippings into the lawn.

Clean up after your pet: Many municipalities and public agencies must enact and enforce local pet-waste rules. An example is requiring pet owners or their keepers to pick up and properly dispose of pet waste dropped on public or other people's property. Make sure you know your town's or agency's requirements and comply with them. It's the law. Remember to use newspaper, bags or "scoopers" to pick up wastes. Dispose of the wrapped pet waste in the trash or unwrapped in a toilet. Never discard pet waste in a storm drain.

Don't feed wildlife: Do not feed wildlife, such a ducks and geese, in public areas. Many municipalities and other public agencies must enact and enforce a rule that prohibits wildlife feeding in these areas.
